INTRODUCTION

It is afraid of meaningful views that are better. This must change. We want everyone's ideas, whichever political party you support in 2022.

We want the people to lead the way, supported by their Government. The Government must stop controlling everything and get behind the people's vision and energy. Governments can legislate, spend money and re-direct resources – but only when guided by a national vision which is clear to everyone so we all know the direction in which we are going. We are bringing to you the vision we wish to share with the people of Fiji when we are in Government. Not every idea is here. But we hope you will see that NFP is ready for leadership. Because, together we are Fiji's future.

This is our time.



OUR VISION FOR FIJI

Our vision of Fiji is of a country and people who work together, live well and enjoy our lives:

- we practise democracy and respect each other's human rights, because this is the best way to live.
- we celebrate diversity and different cultures.
- we work in unity for a resilient and sustainable future against climate change, our children's biggest challenge.
- we work together for good living standards for all through sensible economic development and diversification.

TO KNOW WHERE WE ARE GOING, WE MUST FIRST UNDERSTAND WHERE WE ARE.

We are a nation of hard working and resourceful people. Our country is blessed with fertile soil and tropical weather. We are secure in our island borders and far from major conflicts. We have all we need to be a prosperous, successful and happy country, dealing with the world on our own terms.

But poor leadership and a self-serving, chaotic government have sent us backwards.

- Our current two-man government leadership is tired, self-serving and dictatorial. It listens to no one and works with no one. It cannot unite us; it cannot communicate a vision or a long-term plan for our country.
- Excessive dependence on mass tourism, remittances, and Government borrowing and spending has endangered our economy. We now have back-breaking public debt.
- Our sugar industry, once the bedrock of our economy, has not changed for the last 15-20 years. It is dying because of failed policies.
- In a land of sunshine, rain and rich soil, our non-sugar agriculture development is non-existent. year.
- The Government talks about being climate change "champions" around the world. But at home we allow our environment to be trashed.
- Education is the path to future success. Yet, our education system belongs in the 20th century, not the 21st. Our teachers and school owners and managers should be partners in educational success, not mistreated, bullied and ignored.
- There is no wealth without health. Our public health system is in near-collapse. Our hospitals cannot treat our sick people or give basic medications to the poorest. Our health as a nation is poor. Our adults have some of the highest NCD rates in the world. One child in every classroom may have rheumatic heart disease.

We export \$100m in non-sugar exports a year. Compare this to our fuel imports of \$700 million a

- We have shocking rates of violence and abuse against women and children.
- Our indigenous languages and culture are a unique and precious resource. Yet the institutions of the Taukei have been ignored, demeaned and deemed irrelevant because the Government will not consult with its leaders. It will not acknowledge ethnicity, culture and identity in national life.
- We have no town and city councils because the Fiji First Party cannot control them. Local government services are collapsing because they cannot collect rates. More than \$60 million is owing.
- Our public service should be strong and independent. Now it is politicised and fearful. Public servants are frustrated by bad practices which are all for show but which do not help the people.
- Our religious, social and community organisations are bossed around and their activities restricted. Government leaders are afraid that NGOs will be more popular than them.
- Many young people fear the Police others see it as corrupt, inefficient and politicised.
- Long-term investment and economic stability is threatened as our business people are bullied, frustrated by ever-changing laws and policies and pressure to pay money to the Fiji First Party.
- In foreign policy Fiji has become an unreliable friend, even to our near neighbours Australia and New Zealand, who have supported us through every disaster. Once we led the South Pacific region. Now, through needless fights in the Pacific Forum and at USP we are no longer respected. We diminish democracy by staying silent on human rights abuses in China and our neighbour West Papua.









MAKING OUR VISION WORK

We want to build, with Fiji's people, a shared 20-year vision to make Fiji a better, happier and more prosperous country, in whose success we all share. Not everything will go according to plan. We live in an uncertain world. There will be setbacks and failures. Sometimes we will need to change course but good leadership must keep us all together, working on our common goals.

In a democratic country, different people and parties will lead us over 20 years. We must respect and plan for this. Our Parliamentary system must keep all our political leaders focused on the most important goals, even when we disagree on other things. Governments must be transparent and generous. Oppositions, well-resourced and informed, must hold governments accountable.

This is how a democratic system works for the best results.

4 Our vision is to reduce poverty in Fiji to negligible levels:

Prosperity in Fiji can only come when we can all live well. We must support and uplift those who need help and are living in poverty through:

- Partnerships with NGOs and faith-based organisations who already support vulnerable families, and who know their histories and their needs.
- Direct support through technology and reverse taxation using technology to return money to the needy for essential store-bought items such as food and other groceries.
- Integrated health and welfare systems so that chronically ill people are supported by one system managing their medical, welfare and housing needs.
- Supporting enterprise through training, financial support and infrastructure development – not in wasteful government programmes but supporting people-to-people training and mentorship.

5 Our vision is for a robust and secure business environment where:

- We consult continuously and year-round through the annual National Economic Summit (NES) and permanent NES Secretariat and committees.
- We reduce government interference and bullying. We abolish pointless laws to reduce restrictions and red tape.
- Changes in tax and fiscal measures will be announced 6-12 months before implementation, for long term certainty and stability no surprises.
- We work with business to build voluntary codes of compliance, not sudden new rules and pointless fines and penalties.
- Laws on Employment, Tax and Customs, Transport, FNPF, and company regulation are simplified
- Businesses are rewarded and supported when they invest in community projects.
- Businesses and universities collaborate through research and development to create new "Fiji made" products and services.
- Investors are assured of a secure investment environment without political interference and inconsistent application of law.

6 Our vision for the public service:

is to be an efficient executive arm of the Government dedicated to serving the people with:

- A reformed Public Service Commission with strong, independent leadership and a wellsupported secretariat as the key human resources agency for Government responsible for appointments, discipline and remuneration of public servants. Ministers and Permanent Secretaries cannot choose and promote "favourites".
- A complete overhaul of public service processes removing needless laws and regulations so public servants focus on the right things.
- Digitizing Government files and transforming communications through technology.
- Formal career paths and professional development mechanisms for employees to develop
 rewarding careers in public service with new pay scales for professionally skilled civil servants.
 Doctors and teachers and town planners should not have to leave their skilled work to become
 senior administrators to be paid well they should have their own professional pay scales which
 equal the administrators' pay.
- An end to short-term contrcats and restoring the retirement age to 60 across the civil service and all statutory organisations, government entities and municipal councils.
- Moving some Government departments and staff out of central Suva, improved technology for communications and internal meetings – meaning lower office rents, reduced travel time for employees, reducing politicians' influence, and improving accessibility to the public.
- Improved transparency and accountability by ongoing online public reporting of Government departments' spending against Budget.
- Public servants motivated to innovate and save money, which they can then divert towards approved community projects.
- Businesses and the public services coming together to improve working relationships, share solutions and understand each other's viewpoints. Business is not the enemy!





EDUCATION, WOMEN, YOUTH, **ARTS & SPORTS**

Our vision is for an exemplary education system:

Serving the needs of Fiji and its future. A system where:

- We create an independent National Education Council (NEC) with expert representatives from all education sectors to continuously inform and advise the government on education related policies, best practices, infrastructure needs and planning.
- Teaching becomes a rewarding lifelong career choice and teachers are motivated and wellsupported with clear career objectives, pathways and professional development opportunities Students learn critical thinking, contribute to their communities as part of their education, and
- can learn flexibly.
- School owners have autonomy and the right to organise, fundraise in partnership with their local community and to choose their leaders.
- Schools are centres of the community, including adult education, community consultation and other important community activities.

2 **Our vision for IT Learning:**

- Educational infrastructure is continuously assessed and improved in a planned way with special consideration to remote and marine regions. This includes buildings, playing fields, IT and communications, libraries and vocational training facilities.
- Government uses technology to make education accessible to all students, including remote students.
- Online education resources and social media supplement face-to-face teaching and improve general and civic knowledge.
- There is equity in education for the urban and rural students and there is no "digital divide".

Our vision for Vocational Training: 3

- Vocational training and skills building are integrated into the education spectrum, listening to local communities and businesses about what they need.
- Support for privately run vocational and training programmes.

- Our education and business sectors work together, addressing innovation and business needs, training for future employment demands and positioning our graduates to be successful job holders and job creators.

5 Our vision is for domestic safety and empowerment of women and girls through:

- Partnerships with NGOs and domestic violence advocates (not working against them).
- Targeted legislation, community engagement and support to reduce domestic violence and abuse of women and children.
- Strong, Government-supported NGO advocacy, education, and communal leadership efforts through schools, businesses and community organisations.
- Improved support and resources for victims of domestic violence.
- Developing local training and entrepreneurship building to support women in independent income generation.

- A new approach to public and official information allowing people access to information held by the Government, to improve transparency and accountability.
- A strong national library system where information in paper and electronic form is made available for the public, administered by accredited and upskilled librarians and information professionals.
- Upgrading information resources and library systems in schools, to allow students access to extra-curricular information to allow them to learn research skills and critical thinking.

- Have a special unit in the Government to support community organisations with governance, financial advice and accountability to their stakeholders.
- Bring together these organisations with businesses and international funders to create independent resources for community development in health, education, environmental protection and public facilities. Let the people design and carry out the work themselves. Government does not have to be involved in everything!
- Work with organizations to enhance art, music, performing arts, fashion and other activities that reflect and promote the diverse and rich heritage of all the peoples of Fiji and which bring us together.

8 Our vision for sport is to make it transformative:

- Sports is now a fast-growing global business with huge economic opportunities. We want to partner with businesses, sporting organisations and universities to create a class of Fiji athletes, sporting managers, promoters, physical trainers and therapists who can go confidently into the world, earn good money and promote Fiji.
- We know that sports brings our people together, improves public health and therefore national productivity. We want to turn these ideas into reality.
- An annual Sports Summit will map out strategies not just for the sake of sport but for economic benefit, health and national unity.
- We want strategies for not just major sports like rugby and soccer but also athletics, netball, cricket, volleyball and minor sports.
- We want sportspeople and the disciplined forces to lead the way in promoting sports and recreation for better public health.







- We review the e-ticketing system to make it fairer and more convenient for passengers. This includes alternative payment methods such as cash when the e-ticketing system is not available or not working.
- We investigate more environmentally sensitive transport and information delivery systems using new technology such as electric vehicles and drones.
- We reform communications to minimise the movement of paper and instead work electronically and move goods within Fiji more efficiently.

4 Our vision is for people-focused, effective and robust national infrastructure:

- Ensuring consistent, reliable and affordable water and power with the help of international partners and investors. This is a priority. Until we fix these problems, we cannot grow our economy.
- Reforming our public-private partnership laws to ease private sector investment in infrastructure.
- Focusing our resources on sustainable electricity through hydro, wind, solar and wave power and away from polluting diesel and Heavy Fuel Oil (HFO) generation.



Request the Auditor-General to help the Finance Ministry to cut overspending, waste, pilferage and other losses in Government departments.

Reform Parliament and give the Speaker independent legal support.

RESTORE THE RIGHTS AND FREEDOM OF TRADE UNIONS AND WORKERS

Amend legislation to allow for Right to strike and picket. Strengthen Collective bargaining for all workers. Legislate Right to assembly, free speech and protest. Remove contract employment for civil servants and other public sector employees. Increase civil service retirement age to 60 years. Remove retirement age for municipal workers like other workers. Restore essential services to ILO standards which means only a few industries as legislated previously, instead of all. Increase grievance reporting time for essential workers. Allow individual and collective grievance reporting. Improve dispute settlement processes, including Tribunals. Empower Tribunals and Courts to settle all disputes. Facilitate and host an annual employment summit. Implement and adhere to genuine Tripartism and facilitate within the Tripartite Forum wages and fixing guidelines. Legislate an annual minimum wage review with a view to achieving a living Wage. Put a stop to exploitation of workers by publicly funded contractors. Complete all labour law reviews within the first year of government. Review of FNPF structure by amending FNPF Decree, including governance to restore workers' say in Funds that are 100% owned by them. Restoration of contribution rate of 8% for Employee and 10% for Employer. Restoration of FNPF Pension scheme and contractual obligation to give some security and comfort to retirees. EDUCATION

Awarding scholarships or long term loans to students undertaking any program certain stage in bus fare system.

Appoint an Education Commission to holistically carry out a review of the education sector and come up with a report by end of December 2023.

REDUCING COST OF LIVING

Review duties and charges on imported goods and services. Legislate, as a Budget consequential amendment, charging duty and VAT on FOB or Freight on Board instead of CIF – cost, insurance, freight – as is currently the case to lower costs incurred by businesses. This is to be a temporary measure until the full recovery of the economy.

Increasing the number of zero-rated or VAT-free essential goods to include prescribed medication.

HEALTH



Develop a budget strategy to get the Health Ministry funded to \$500 million per annum or the required WHO international benchmark by second year in office.

Reviewing the procurement procedures of medication at Fiji Pharmaceutical Services to ensure availability of medicine at all times. Repealing all laws that compromise the recruitment of medical personnel and establishment if pharmacies v that were enacted by Parliament through the Fiji First

government.

A holistic inquiry into all aspects of public health and medical services delivery with an aim to ensure immediate improvement to basic services within six months and positive changes to diagnostics, advanced medical care and surgeries by early 2024.

TERMITE INVASION



Address the issue of termite invasion that has for more than a decade cased millions of dollars in damage by severely damaging homes in Lautoka and is now spreading to other districts.
